ICQ provides global leadership and a hub for organizations interested in promoting and improving the quality of substance use disorders (SUDs) treatment services and systems to ensure the best positive outcomes for people who use alcohol and other drugs.

ICQ was created to ensure that SUDs services and systems are in line with international standards for the treatment of SUDs through peer-led and co-designed resources and through the provision of technical support to interested countries from two international initiatives:

- ▶ International Consortium on Quality in Substance Use Disorders Treatment (ICQ)
- ▶ Program for International Quality Assurance in Treatment (PIQAT)

Through ICQ and PIQAT, quality and quality assurance in a country's system of care and services will be embedded and sustained through continuous quality improvement processes as reflected in International Standards and guidance.
